- **SUBJECT:** Financial Audit of USAID Resources Managed by Integrated Services on Health and Development Organization in Ethiopia Under Multiple Awards, January I to December 31, 2021 (Report No. 4-663-23-004-R)

This memorandum transmits the final audit report on USAID resources managed by Integrated Services on Health and Development Organization (ISHDO) under 1) cooperative agreement 72066320CA00013, Family Focused HIV Prevention, Care and Treatment Activity, and 2) subagreement under PSI's Mulu: Key Populations Project (72066318CA0001). ISHDO contracted with the independent audit firm Tensae and Zelalem TZ Audit Partnership, Addis Ababa, Ethiopia to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards. However, it did not have an external peer review or a continuing professional education program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on ISHDO's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.¹

The audit objectives were to (1) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate ISHDO's internal controls; (3) determine whether ISHDO complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, TZ Audit Partnership (1) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by ISHDO as incurred from January 1 to December 31, 2021; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to

Desk reviews are limited to review of the audit report itself and excludes review of the auditor's supporting working papers; they are not designed to enable us to directly evaluate the quality of the audit performed.

ISHDO's ability to report financial data consistent with the assertions embodied in each account of the schedule of expenditures of USAID awards; (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. ISHDO reported expenditures of \$3,711,030 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited. The audit firm identified no questioned costs; no material weaknesses in internal control; and one instance of material noncompliance.

During our desk review, we noted several areas for improvement which the audit firm should address in future audit reports. We presented these areas in a memo to the controller, dated October 24, 2022.

To address the issue identified in the report, we recommend that USAID/Ethiopia:

Recommendation I. Verify that Integrated Services on Health and Development Organization corrects the one instance of material noncompliance detailed on page 23 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision.
