SUBJECT: Financial Audit of USAID Resources Managed by Centre for Communication Impact NPC in South Africa Under Multiple Awards, July 1, 2021, to June 30, 2022 (Report No. 4-674-23-068-R)

This memorandum transmits the final audit report on USAID resources managed by Centre for Communication Impact NPC (CCI), under 1) cooperative agreement AID-674-A-14-00012, Community Based Comprehensive HIV Prevention Counselling and Testing Program to Reduce HIV Incidence Programmes, and 2) cooperative agreement 72067418CA00008, Local Governance to Improve Gender Based Violence Response Project. CCI contracted with the independent audit firm BDO South Africa Inc., Cape Town, South Africa to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards. However, it did not have an external peer review program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on CCI's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.¹

The audit objectives were to (1) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate CCI's internal controls; (3) determine whether CCI complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, BDO (1) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by CCI as incurred from July 1, 2021, to June 30, 2022; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to CCI's ability to report financial data

Desk reviews are limited to review of the audit report itself and excludes review of the auditor's supporting working papers; they are not designed to enable us to directly evaluate the quality of the audit performed.

consistent with the assertions embodied in each account of the schedule of expenditures of USAID awards; (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. CCI reported expenditures of \$5,480,907 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited. The audit firm identified \$30,146 in ineligible questioned costs; no material weaknesses in internal control; and one instance of material noncompliance. In addition, although we are not making a recommendation for significant deficiency noted in the report, we suggest that USAID/Southern Africa determine if the recipient addressed the issue noted. The audit firm also issued a management letter.

During our desk review, we noted several areas for improvement which the audit firm should address in future audit reports. We presented these areas in a memo to the controller, dated April 26, 2023.

To address the issues identified in the report, we recommend that USAID/Southern Africa:

Recommendation 1. Determine the allowability of \$30,146 in ineligible questioned costs on pages 11 and 16 of the audit report and recover any amount that is unallowable.

Recommendation 2. Verify that Centre for Communication Impact NPC corrects the one instance of material noncompliance detailed on page 32 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision.
