SUBJECT: Financial Audit of USAID Resources Managed by KNCV Tuberculosis Foundation

This memorandum transmits the final audit report on USAID resources managed by KNCV Tuberculosis Foundation Nigeria (KNCV Nigeria) under the Tuberculosis Local Organizations Network Nigeria (TB LON Nigeria) Regions I and 2 Project. KNCV Nigeria contracted with the independent audit firm Parker Randall Offor, Lagos, Nigeria to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards. However, it did not have an external peer review and a continuing professional education program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on KNCV Nigeria's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations. I

The audit objectives were to (I) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate KNCV Nigeria's internal controls; (3) determine whether KNCV Nigeria complied with award terms and applicable laws and regulations; (4) determine if recipient applied the indirect cost rate according to the agreement; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, Parker Randall Offor (I) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by KNCV Nigeria as incurred from October I, 202I, to September 30, 2022; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to KNCV Nigeria's ability to report financial data consistent with the assertions

embodied in each account of the schedule of expenditures of USAID awards; (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined that the recipient applied the indirect cost rate according to the agreement; and (5) reviewed the implementation status of the prior period recommendations. KNCV Nigeria reported expenditures of \$9,066,633 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited. The audit firm identified no questioned costs; two material weaknesses in internal control; and one instance of material noncompliance. The audit firm issued a management letter.

During our desk review, we noted several areas for improvement which the audit firm should address in future audit reports. We presented these areas in a memo to the controller, dated July 5, 2023.

To address the issues identified in the report, we recommend that USAID/Nigeria:

Recommendation 1. Verify that KNCV Tuberculosis Foundation Nigeria corrects the two material weaknesses in internal control detailed on pages 22 and 23 of the audit report.

Recommendation 2. Verify that KNCV Tuberculosis Foundation Nigeria corrects the one instance of material noncompliance detailed on page 26 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision.
