SUBJECT: Financial Audit of USAID Resources Managed by Maternal, Adolescent and Child

Health Institute NPC in South Africa Under Multiple Awards, October 1, 2021, to

September 30, 2022 (Report No. 4-674-23-096-R)

This memorandum transmits the final audit report on USAID resources managed by Maternal, Adolescent and Child Health Institute NPC (MatCH) under the following awards: I) Accelerating Program Achievement to Control the Epidemic (APACE) Program, cooperative agreement 72067418CA00025, and 2) Safeguarding Advances in TB Treatment by Strengthening the MDR TB Health Care Platform (TB LON), a subagreement under THINK Tuberculosis and HIV Investigative Network RF NPC. MatCH contracted with the independent audit firm PricewaterhouseCoopers Inc., Durban, South Africa to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards. However, it did not have an external peer review program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on MatCH's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.¹

The audit objectives were to (I) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate MatCH's internal controls; (3) determine whether MatCH complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, PricewaterhouseCoopers Inc. (I) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by MatCH as incurred from October I, 2021, to September 30, 2022; (2) evaluated

the control environment, the adequacy of the accounting systems, and control procedures that pertain to MatCH's ability to report financial data consistent with the assertions embodied in each account of the schedule of expenditures of USAID awards; (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. MatCH reported expenditures of \$16,886,620 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited. The audit firm identified no questioned costs; no material weaknesses in internal control; and no instances of material noncompliance. The audit firm also issued a management letter.

Accordingly, we are not making any recommendations.

During our desk review, we noted several areas for improvement which the audit firm should address in future audit reports. We presented these areas in a memo to the controller, dated July 26, 2023.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4)("commercial or financial information obtained from a person that is privileged or confidential"). In addition, USAID OIG has determined that this transmittal memo and the enclosed report are not subject to notification and reporting requirements under Section 5274 of the National Defense Authorization Act.²
