**SUBJECT:** Financial Audit of USAID Resources Managed by Georgetown Global Health Nigeria Under Cooperative Agreement 72062022CA00005, February 1 to December 31, 2022 (Report No. 4-620-23-115-R)

This memorandum transmits the final audit report on USAID resources managed by Georgetown Global Health Nigeria LTD/GTE (GGHN) under the Accelerating Control of the HIV Epidemic in Nigeria (ACE 2: Bauchi, Kano and Jigawa States) project. GGHN contracted with the independent audit firm Olufemi Adeniji & Co., Abuja, Nigeria to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards. However, it did not have an external peer review or a continuing professional education program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on GGHN's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.<sup>1</sup>

The audit objectives were to (1) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate GGHN's internal controls; (3) determine whether GGHN complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, Olufemi Adeniji & Co. (1) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by GGHN as incurred from February 1 to December 31, 2022; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to GGHN's ability to report financial data consistent with the assertions embodied in each account of the schedule of expenditures of USAID awards; (3) identified the award terms and

pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. GGHN reported expenditures of \$5,385,625 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited. The audit firm identified no questioned costs; one material weakness in internal control; and one instance of material noncompliance. The audit firm also issued a management letter.

During our desk review, we noted an area for improvement which the audit firm should address in future audit reports. We presented this area in a memo to the controller, dated September 7, 2023.

To address the issues identified in the report, we recommend that USAID/Nigeria:

**Recommendation 1.** Verify that Georgetown Global Health Nigeria corrects the one material weakness in internal control detailed on page 21 of the audit report.

**Recommendation 2.** Verify that Georgetown Global Health Nigeria corrects the one instance of material noncompliance detailed on page 25 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4) ("commercial or financial information obtained from a person that is privileged or confidential").
