



# COP-OCO IN BRIEF

The 9th annual comprehensive oversight plan is a whole-of-government effort involving 13 federal agencies with oversight responsibility for different aspects of overseas contingency operations. Operation Inherent Resolve (OIR) in Iraq and Syria and Operation Enduring Sentinel (OES) in Afghanistan will continue into FY 2024. This comprehensive oversight plan contains 97 ongoing and planned oversight projects for FY 2024, some of which apply to multiple overseas contingency operations.

## Lead IG Oversight Objectives

- Inform Congress and the public about progress and challenges in contingency operations
- Advise DoD, State, and USAID on the effectiveness of their missions
- Promote the integrity, efficiency, and accountability of U.S. Government programs
- Assess the impact of U.S. Government programs
- Evaluate the safety and security of U.S. installations and personnel
