SUBJECT: Audit of the Schedule of Expenditures of Independent Election Commission of Jordan, IEC Partnership Program, Implementation letter 278-IL-DO2-IEC-IPP-01, January I to December 31, 2022 (8-278-23-023-N)

This memorandum transmits the final audit report on the schedule of expenditures of Independent Election Commission, IEC Partnership program in Jordan, implementation letter 278-IL-DO2-IEC-IPP-01, from January I to December 31, 2022. USAID/Jordan contracted with the independent audit firm Baker Tilly to conduct the audit. The audit firm stated that it performed the audit in accordance with U.S. Generally Accepted Government Auditing Standards. However, it did not have an external quality control review program because professional organizations in Jordan do not offer such a program. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on the auditee's schedule of expenditures; the effectiveness of its internal controls; or its compliance with the award, laws, and regulations.<sup>1</sup>

The audit objectives were mainly to: (1) express an opinion on whether the schedule of expenditures for the period audited was presented fairly, in all material respects; (2) evaluate the auditee's internal controls; and (3) determine whether the auditee complied with the award terms and applicable laws and regulations. To answer the audit objectives, the audit firm

performed the subject financial audit that covered \$940,507 from January 1 to December 31, 2022.

The audit firm concluded that the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited and did not identify any questioned costs. The audit firm did not identify any material internal control weaknesses or any material instances of noncompliance with the award's terms, conditions and applicable laws and regulations. In addition, the audit firm identified three significant internal control deficiencies and stated that they were closed.

During our desk review, we noted an area for improvement which the audit firm should address in future audit reports. We presented this deficiency in a memo to the controller, dated September 27, 2023.

The report does not contain any recommendations for your action.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4)("commercial or financial information obtained from a person that is privileged or confidential"). In addition, USAID OIG has determined that this transmittal memo and the enclosed report are not subject to notification and reporting requirements under Section 5274 of the National Defense Authorization Act.<sup>2</sup>
