**SUBJECT:** Financial Audit of USAID Resources Managed by Mary Joy Development Association in Ethiopia Under Agreement 72066320CA00015, January 1 to December 31, 2022 (Report No. 4-663-24-042-R)

This memorandum transmits the final audit report on USAID resources managed by Mary Joy Development Association in Ethiopia, under the project entitled “Family Focused HIV Prevention, Care, and Treatment Services in SNNPR and Sidama Regions.” Mary Joy Development Association contracted with the independent audit firm TAY Authorized Accountants and Auditors, Addis Ababa, Ethiopia to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards. However, it did not have an external peer review or a continuing professional education program that fully satisfy the standards’ requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on Mary Joy Development Association’s schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.<sup>1</sup>

The audit objectives were to (1) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate Mary Joy Development Association’s internal controls; (3) determine whether Mary Joy Development Association complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, TAY Authorized Accountants and Auditors (1) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by Mary Joy Development Association as incurred from January 1 to December 31, 2022; (2) evaluated the control environment, the adequacy of the accounting

systems, and control procedures that pertain to Mary Joy Development Association's ability to report financial data consistent with the assertions embodied in each account of the schedule of expenditures of USAID awards; (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. Mary Joy Development Association reported expenditures of \$1,583,892 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited. The audit firm identified \$1,015 in ineligible questioned costs; no material weaknesses in internal control; and two instances of material noncompliance. Since the questioned costs did not meet the OIG's established threshold of \$25,000 for making a recommendation, we are not making a recommendation for the questioned costs and the specifically related material noncompliance instance (item 12.2 on page 21). Nevertheless, we suggest that USAID/Ethiopia determine the allowability of the \$1,015 in questioned costs and recover any amount determined to be unallowable. In addition, although we are not making a recommendation for the other findings on the schedule of expenditures of USAID award noted in the report, we suggest that USAID/Ethiopia determine if the recipient addressed the issues noted. The audit firm also issued a management letter.

During our desk review, we noted several areas for improvement which the audit firm should address in future audit reports. We presented these areas in a memo to the controller, dated November 29, 2023.

To address the issues identified in the report, we recommend that USAID/Ethiopia

**Recommendation I.** Verify that Mary Joy Development Association corrects the one instance of material noncompliance detailed on page 21 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision.
