SUBJECT: Audit of Incurred Costs for the Development Innovations Group for Fiscal Year

Ended December 31, 2020 (3-000-24-030-I)

This memorandum transmits the final audit report on incurred costs submission (ICS) for the Development Innovations Group (DIG) for Fiscal Year (FY) Ended December 31, 2020. The U.S. Agency for International Development (USAID) Office of Acquisition and Assistance, Cost, Audit and Support Division, Contract Audit Management Branch contracted with the independent certified public accounting firm of Brown & Company CPAs and Management Consultants, PLLC (Brown) to conduct the audit. Brown stated that it performed its audit in accordance with government auditing standards issued by the Comptroller General of United States. Brown is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on whether costs claimed by DIG, in its FY 2020 ICS are accurate, allowable, allocable, and reasonable in accordance with contract terms and applicable Government acquisition regulations. The audit objectives were to determine whether: (1) DIG's costs claimed in-scope contracts and subcontracts for FY 2020 are allowable, allocable, and reasonable in accordance with contract terms; Part 31 of the Federal Acquisition Regulation (FAR); Agency for International Development Acquisition Regulation (AIDAR); Department of State Standardized Regulation (DSSR); and 2 Code of Federal Regulations (CFR) 200, and (2) DIG's proposed direct and indirect amounts for contract reimbursement on USAID unsettled flexibly priced contracts contained in its FY 2020 Incurred Cost Proposal (ICP), revised April 1, 2022, complied with the criteria in (1) and with the contract terms. To answer the audit's objectives, Brown (1) identified closed Government cost-type, flexibly priced, time and material contracts and subcontracts for FY 2020; (2) reconciled adjusted total costs booked and the cumulative amount billed by contract, for FY 2020 and report over or under billings; (3) determined whether any contract limitations

were applicable during FY 2020 and whether the cumulative amount billed for each contract exceeded the total funded value on the contract at that point in time; (4) performed a risk and materiality assessment of DIG using procedures from newly enacted guidance developed by a Department of Defense Procurement Panel; (5) reviewed the claimed costs reported in the ICP for compliance with the applicable requirements; and (6) evaluated and determined whether DIG's claimed executive compensation was allowable and reasonable. Brown examined claimed and allowable costs of \$4,427,009 for FY 2020.

Brown concluded that DIG's costs claimed for in-scope contracts and subcontracts for FY 2020 are allowable, allocable, and reasonable in accordance with contract terms, Part 31 of the FAR, AIDAR, DSSR, and 2 CFR 200. Further, Brown did not identify any direct or indirect questioned costs. Finally, Brown did not note any instances of material non-compliance with laws, regulations, or contract terms required to be reported under Government Auditing Standards during the FY 2020 audit.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4)("commercial or financial information obtained from a person that is privileged or confidential"). In addition, USAID OIG has determined that this transmittal memo and the enclosed report are not subject to notification and reporting requirements under Section 5274 of the National Defense Authorization Act.²
