This memorandum transmits the final audit report on the cost representation statement closeout audit of USAID resources managed by DPK Consulting, Rule of Law, Justice and Empowerment project, West Bank and Gaza, Contract DFD-I-00-04-00173-00, from July I, 2009 to October 30, 2010. USAID contracted with the independent certified public accounting firm Deloitte & Touche (M.E.) to conduct the audit. The contract required the audit firm to perform the audit in accordance with generally accepted government auditing standards and the USAID OIG Guidelines for Financial Audits Contracted by Foreign Recipients¹.

¹ On June 30, 2017, USAID OIG rescinded its Guidelines for Financial Audits Contracted by Foreign Recipients, recognizing the Agency's role to impose requirements on its implementing partners and contractors as a management function. This contracted audit, however, was initiated before that date and follows the Guidelines.

The audit firm states it performed its audit in accordance with generally accepted government auditing standards except that it did not participate in an external quality control review program. The audit firm says that West Bank and Gaza does not offer such a review program. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on DPK Consulting Cost Representation Statement; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.²

The audit objectives were mainly to: (1) express an opinion on whether the Cost Representation Statement for the period July 1, 2009 to October 30, 2010, was presented fairly, in all material respects; (2) evaluate DPK Consulting's internal controls; and (3) determine whether DPK Consulting complied with the award terms and applicable laws and regulations. To answer the audit objectives, the auditors performed the subject financial audit that covered \$4,517,513 in expenditures for the period July 1, 2009 to October 30, 2010.

The audit firm expressed an unmodified opinion on the cost representation statement and did not identify any question costs. The audit firm did not identify any significant deficiencies or material weaknesses in internal control. The audit firm did not identify any material instances of noncompliance with the award terms and applicable laws and regulations. The auditors also did not identify any material instances of noncompliance with Executive Order 13224.

The report does not contain any recommendations for your action.
