SUBJECT: Financial Audit of MCC Resources Managed by FOMILENIO II Under the Compact Agreement Between MCC and the Government of El Salvador, April 1, 2016, to March 31, 2017 (M-519-19-002-N)

This memorandum transmits the final audit report on MCC Resources Managed by FOMILENIO II, for the period from April 1, 2016, to March 31, 2017. FOMILENIO II contracted with the independent certified public accounting firm PricewaterhouseCoopers (PwC) to conduct the audit. The contract required the audit firm to perform the audit in accordance with generally accepted government auditing standards and OIG's Guidelines for Financial Audits Contracted by the Millennium Challenge Corporation's Accountable Entities.¹

The audit firm states that it performed its audit in accordance with generally accepted government auditing standards except that the audit firm did not have an external peer review because no such program is offered in El Salvador. The audit firm reported that it did not believe that the effect of this departure was material because it participates in PwC's worldwide internal quality control review program which requires the office to be annually subjected to an extensive quality control review. The audit firm also acknowledged it did not have a continuing professional education program that fully satisfies the requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on FOMILENIO II's fund accountability statement; the effectiveness of its internal

control; or its compliance with the agreement, laws, and regulations.²

The audit objectives were to (1) express an opinion on whether the fund accountability statement for the period audited, was presented fairly, in all material respects; (2) evaluate FOMILENIO II's internal controls; (3) determine whether FOMILENIO II complied with agreement terms and applicable laws and regulations; and (4) review the cost-sharing schedule. To answer the audit objectives, the audit firm conducted an audit of MCC resources managed by FOMILENIO II for the period from April 1, 2016, to March 31, 2017. Costs incurred for this period were \$7,231,767.

The audit firm concluded the fund accountability statement presented fairly, in all material respects, program revenues, costs incurred and reimbursed, and assets and technical assistance procured directly by MCC for the period audited. The audit firm did not identify any significant deficiencies or material weaknesses in internal control or material instances of noncompliance that were required to be reported. In addition, nothing came to the attention of the audit firm that caused them to believe that the cost-sharing schedule was not presented fairly, in all material respects, in accordance with the basis of accounting used to prepare the schedule. The audit firm issued a management letter that noted one matter involving internal control.

We appreciate the assistance extended during the engagement.

Desk reviews are limited to review of the audit report itself and excludes review of the auditor's supporting working papers; they are not designed to enable us to directly evaluate the quality of the audit performed.
