**SUBJECT:** Closeout Audit of the Fund Accountability Statement of Peres Center for Peace

and Innovation, Business to Business Program in West Bank and Gaza,

Cooperative Agreement AID-294-A-15-00007, January 1, 2017 to June 30, 2018

This memorandum transmits the final closeout audit report on the fund accountability statement of Peres Center for Peace and Innovation, Business to Business Program in West Bank and Gaza, cooperative agreement AID-294-A-15-00007, from January 1, 2017 to June 30, 2018. Peres Center for Peace and Innovation contracted with the independent certified public accounting firm El Wafa Company to conduct the audit. The audit firm stated that it performed its audit in accordance with the U.S. Government Auditing Standards issued by the Comptroller General of the United States. However, it did not have an external quality control review program. The auditors stated that West Bank and Gaza does not offer such a review program. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on Peres Center for Peace and Innovation's fund accountability statement; the effectiveness of its internal control; or its compliance with the award, laws, and regulations. The audit objectives were mainly to: (I) express an opinion on whether the fund accountability statement for the period audited was presented fairly, in all material respects; (2) evaluate the auditee's internal controls; and (3) determine whether the auditee complied with the award terms and applicable laws and regulations, including compliance with executive order 13224 – Blocking Property and Prohibiting Transactions With Persons Who Commit, Threaten to

Our desk reviews are typically performed to identify any items needing clarification or issues requiring management attention. Desk reviews are limited to review of the audit report itself and excludes review of the auditor's supporting working papers; they are not designed to enable us to directly evaluate the quality of the audit performed.

Commit, or Support Terrorism. To answer the audit objectives, the audit firm performed the subject financial audit that covered \$761,580 for the period from January 1, 2017 to June 30, 2018.

The auditors expressed an unmodified opinion on the fund accountability statement and did not identify any questioned costs. The audit firm did not identify any material weaknesses in internal control, or any material instances of noncompliance with the agreement terms and applicable laws and regulations. The auditors also did not identify any material instances of noncompliance with Executive Order 13224.

During our desk review, we noted a minor issue which the audit firm will need to address in its future audit reports. We presented this issue in a letter to the controller dated April 27, 2020. Please note that page 23 of the audit report includes personally identifiable information.

The report does not include any recommendations for your action.
