**SUBJECT:** Closeout Financial Audit of the National HIV/STI Programme, Managed by the Ministry of Health & Wellness in Jamaica, Program Assistance 532-DOAG-2013-JM, IL 532-IL-532-HE-DOAG-00006/6.1, April 1, 2019 to September 30, 2019 (9-532-21-015-R)

This memorandum transmits the final audit report on National HIV/STI Programme, Managed by the Ministry of Health & Wellness (MOHW) in Jamaica. MOHW contracted with the independent certified public accounting firm BDO Jamaica to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards. However, it did not have a continuing education program that fully complies with GAGAS requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on MOHW's fund accountability statement; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.<sup>1</sup>

The audit objectives were to (1) express an opinion on whether the fund accountability statement for the period audited, was presented fairly, in all material respects; (2) evaluate MOHW's internal controls; (3) determine whether MOHW complied with award terms and applicable laws and regulations; and (4) determine if cost-sharing/counterpart contributions were made and accounted for by MOHW in accordance with the terms of the agreement. To answer the audit objectives, the audit firm reported that they assessed and tested the internal controls related to the project; compliance with applicable laws, regulations, the agreement's

provisions; and reviewed project expenditures. The audit covered \$1,393,933 of USAID expenditures for the audited period.

The audit firm concluded the fund accountability statement presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited.

The audit firm did not identify any material weaknesses in internal control or instances of material noncompliance with applicable laws, regulations, and agreement terms. The audit firm issued a management letter which included minor internal control deficiencies.

The audit firm stated that based on their review, nothing came to their attention that caused them to believe that MOHW did not fairly present the cost sharing/counterpart contributions schedule, in all material respects, in accordance with the basis of accounting used to prepare the cost sharing/counterpart contributions schedule.

Based on the results of the desk review, OIG is not making any recommendation to USAID/Jamaica.
