**SUBJECT:** Financial Audit of Danish Refugee Council Under Multiple Awards, for the Fiscal Year Ended December 31, 2018 (3-000-21-017-R)

This memorandum transmits the final audit report on the recipient contracted audit of Danish Refugee Council (DRC) under multiple awards for the fiscal year ended December 31, 2018. DRC contracted with the independent certified public accounting firm Deloitte Denmark to conduct the recipient contracted audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards (GAGAS) and the USAID Financial Audit Guide for Foreign Organizations. However, it did not have a continuing education program that fully complies with GAGAS requirements and an external peer review because such a program is not offered in Denmark. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on DRC's fund accountability statement; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.<sup>1</sup>

The audit objectives were to: (1) express an opinion on whether the fund accountability statement for the period audited was presented fairly, in all material respects; (2) evaluate DRC's internal controls; (3) determine whether DRC complied with award terms and applicable laws and regulations; (4) determine if cost-sharing contributions were made and accounted for by DRC in accordance with the terms of the agreements; (5) perform an audit of the indirect cost rate; and (6) perform an audit of the general purpose financial statements. To answer the audit objectives, the audit firm reported that it assessed and tested the internal controls related to the project, tested compliance with applicable laws, regulations, and award

terms; and reviewed project expenditures. The report on the fund accountability statement disclosed that the U.S. Agency for International Development's (USAID) audited expenditures were \$33,356,288 for the fiscal year ended December 31, 2018.

The audit firm concluded that the fund accountability statement presented fairly, in all material respects, program revenues, costs incurred and reimbursed, and commodities and technical assistance directly procured by USAID for the year ended December 31, 2018, in accordance with the terms of the awards and in conformity with the accrual basis of accounting. The audit firm did not identify any material weaknesses in internal control or instances of material noncompliance with applicable laws, regulations, and award terms. The audit firm stated that based on its review, nothing came to its attention that caused it to believe that DRC did not fairly present the cost sharing contributions schedule, in all material respects, in accordance with the basis of accounting used to prepare the cost sharing contributions schedule. The audit firm concluded the financial statements presented fairly, in all material respects, the financial position of DRC as of December 31, 2018. Furthermore, the audit firm stated that the schedule of computation of indirect cost rate was fairly stated in all material respects in relation to the basic financial statements taken as whole.
