This memorandum transmits the final audit report on Feed the Future Guatemala, Coffee Value Chains Project. Federación de Cooperativas Agrícolas de Productores de Café de Guatemala (FEDECOCAGUA) contracted with the independent certified public accounting firm García Sierra y Asociados, S.C. to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards. However, it did not have a continuing education program that fully complied with GAGAS requirements or an external peer review because such program is not offered in Guatemala. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on FEDECOCAGUA's fund accountability statement; the effectiveness of its internal control; or its compliance with the award, laws, and regulations. I

The audit objectives were to (I) express an opinion on whether the fund accountability statement for the period audited, was presented fairly, in all material respects; (2) evaluate FEDECOCAGUA's internal controls; (3) determine whether FEDECOCAGUA complied with award terms and applicable laws and regulations; and (4) determine if cost-sharing contributions were made and accounted for by FEDECOCAGUA in accordance with the terms of the agreement. To answer the audit objectives, the audit firm reported that they assessed and tested the internal controls related to the project; assessed and tested compliance with applicable

laws, regulations, the agreement's provisions; and reviewed project expenditures. The audit covered \$3,830,246 of USAID expenditures for the audited period.

The audit firm concluded the fund accountability statement presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited.

The audit firm did not identify any material weaknesses in internal control or instances of material noncompliance with applicable laws, regulations, and agreement terms.

The audit firm stated that based on their review, nothing came to their attention that caused them to believe that FEDECOCAGUA did not fairly present the cost sharing contributions schedule, in all material respects, in accordance with the basis of accounting used to prepare the cost sharing contributions schedule.

Based on the results of the desk review, OIG is not making any recommendation to USAID/Guatemala.
