SUBJECT:	Examination of Incurred Costs Claimed on Flexibly Priced Contracts by TerraTherm, Inc. for the Fiscal Year Ended December 31, 2018 (3-000-22-016-1)

This memorandum transmits the final examination report on Incurred costs claimed on flexibly priced contracts by TerraTherm, Inc. (TerraTherm) for the Fiscal Year Ended December 31, 2018. The U.S. Agency for International Development (USAID) Office of Acquisition and Assistance, Cost, Audit, and Support Division contracted with the independent certified public accounting firm of Booth Management Consulting, LLC (BMC) to conduct the examination. The audit firm stated that it performed its examination in accordance with attestation standards established by the American Institute of Certified Public Accountants and the standards applicable to attestation engagements contained in generally accepted government auditing standards. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on whether costs claimed by TerraTherm on in-scope contracts and subcontracts for the fiscal year ended December 31, 2018 are allowable, allocable and reasonable in accordance with contract terms; Part 31 of the Federal Acquisition Regulation (FAR); Agency for International Development Acquisition Regulation (AIDAR); Department of State Standardized Regulation (DSSR); and 2 Code of Federal Regulations (CFR) 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards, as applicable.¹

The examination's objective was to express an opinion on whether the costs claimed by TerraTherm on in-scope contracts and subcontracts for the fiscal year ended December 31, 2018 are allowable, allocable, and reasonable in accordance with contract terms; Part 31 of the FAR; AIDAR; DSSR; and 2 CFR 200, *Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards*, as applicable. To answer the examination's objective, BMC designed its testing procedures to evaluate the internal control environment surrounding TerraTherm's subcontract management process and to verify that TerraTherm had adequate controls in place for monitoring subcontractor costs. Its examination included the reconciliation of the adjusted total costs booked to date and the cumulative amount billed, by

contract or subcontract and reporting any over/under-billings. The audit firm examined USAID incurred costs of \$3,973,539 for the fiscal year ended December 31, 2018.

BMC expressed a qualified opinion due to submitted amounts that did not materially comply with contract terms pertaining to accumulating and billing incurred amounts. According to BMC, except for the instances of non-compliance described below, costs claimed by TerraTherm on in-scope contracts and subcontracts for the fiscal year ended December 31, 2018 are allowable, allocable, and reasonable in accordance with contract terms; Part 31 of the FAR; AIDAR; DSSR; and 2 CFR 200, *Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards,* as applicable. The audit firm identified \$6,642 in total direct questioned costs (\$6,642 unsupported) and indirect questioned costs of \$8,528 in General & Administrative pool costs. The audit firm's examination did not disclose any findings that are required to be reported under government auditing standards. Since the questioned costs did not meet the OIG's established threshold of \$25,000 for making a recommendation, we are not making a recommendation. Nevertheless, we suggest that USAID/Management/Office of Acquisition and Assistance/Cost Audit and Support Division determine the allowability of the \$6,642 in questioned costs and recover any amount determined to be unallowable.
