This memorandum transmits the final audit report of the fund accountability statement of Leo Baeck Education Center, Building Shared Communities program in West Bank and Gaza, cooperative agreement 294-19-CA-00004, from September 3, 2019 to December 31, 2020. USAID/West Bank and Gaza contracted with the independent certified public accounting firm Ernst & Young – Middle East to conduct the audit. The audit firm stated that it performed the audit in accordance with U.S. Government auditing standards. However, it did not have an external quality control review program because professional organizations in West Bank and Gaza do not offer such a program. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on the auditee's fund accountability statement; the effectiveness of its internal controls; or its compliance with the award, laws, and regulations.¹

The audit objectives were mainly to: (1) express an opinion on whether the fund accountability statement for the period audited was presented fairly, in all material respects; (2) evaluate the auditee's internal controls; and (3) determine whether the auditee complied with the award terms and applicable laws and regulations. To answer the audit objectives, the audit firm

performed the subject financial audit that covered \$274,404, from September 3, 2019 to December 31, 2020.

The audit firm expressed a qualified opinion on the fund accountability statement and identified \$1,645 of total questioned costs (ineligible costs \$1,101 and unsupported costs \$544). The audit firm did not identify material internal control weaknesses. The audit report indicated that the amount of \$1,645 of total questioned costs was returned by Leo Baeck Education Center to USAID in May 2021. The auditor identified three material instances of noncompliance with the agreement's terms, conditions and applicable laws and regulations. The audit firm said that the program is not subject to mission order number 21 and executive order number 13224, as it falls outside the scope of the mandatory provisions underlying mission order number 21.

In addition, although we are not making a recommendation for the significant deficiencies noted in the report, we suggest that USAID/West Bank and Gaza determine if the recipient addressed the issues noted. The audit firm issued a management letter.

To address the issues identified in the report, we recommend that USAID/West Bank and Gaza:

Recommendation I. Verify that Leo Baeck Education Center corrects the three material instances of noncompliance, as detailed on pages 18, 19, and 20 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decisions.
