HQ-HQ-22-1130- G		Closed	In April 2022, OIG received information that a sub-grantee of an implementer suspended their operation due to the escalation of hostilities in Mariupol, Ukraine.
LA-H0-22-1294-G	disruption due to military conflict	Closed	In April 2022, OIG received information from an implementer that was unable to spend funding due to the ongoing conflict in Mariupol, Ukraine.
HQ-HQ-22-1164-R	Theft/Diversion	Closed	In April 2022, OIG received information from a Public International Organization (PIO) that supplies were stolen in Lviv, Ukraine. OIG referred the case to USAID/Bureau for Policy, Planning, and Learning.
LA-H0-22-1432-G	Closed	In June 2022, OIG received information from an implementer that a manager in Ukraine asked an employee to participate in an incentive-based payment scheme on construction work that was already completed. The employee declined to participate in the scheme and notified the implementer's Ukraine Country Director of the potential fraud.	
False Claim  LA-H0-22-1433-G  Closed		Closed	In June 2022, OIG received information from an implementer reporting false incentive payments. The report alleged that an International Non-Governmental Organization inquired about payments for the procurement of medical supplies as part of a possible fraud scheme.

AF-FR-22-1088-G	Conflict of Interest/Ethics	Closed	In April 2022, OIG received information alleging that an employee of a USAID implementing partner gave an unfair competitive advantage to thirteen local firms. There were no allegations of bribery or kickbacks; therefore, OIG did not pursue the case.
