SUBJECT: Performance Audit of Incurred Costs for Remote Medicine, Inc. for Fiscal Year Ended December 31, 2020 (3-000-24-017-I)

This memorandum transmits the final performance audit report on incurred costs claimed on flexible priced contracts for Remote Medicine, Inc. (RMI) for Fiscal Year (FY) Ended December 31, 2020. The U.S. Agency for International Development, Office of Acquisition and Assistance, Cost, Audit and Support Division, Contract Audit Management Branch contracted with the independent certified public accounting firm of Brown & Company CPAs and Management Consultants, PLLC (Brown) to conduct the audit. Brown stated that it performed its audit in accordance with government auditing standards issued by the Comptroller General of United States. Brown is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on whether costs claimed by RMI, in its FY 2020 awards and subawards are accurate, allowable, allocable, and reasonable in accordance with contract terms and applicable Government acquisition regulations.¹

The audit objective was to determine whether the costs claimed by RMI's in-scope contracts and subcontracts for FY 2020 are allowable, allocable, and reasonable in accordance with contract terms; Part 31 of the Federal Acquisition Regulation (FAR); Agency for International Development Acquisition Regulation (AIDAR); Department of State Standardized Regulation (DSSR); and 2 Code of Federal Regulations (CFR) 200. To answer the audit's objective, Brown (1) identified Government cost-type, flexibly priced, time and material closed contracts and subcontracts for FY 2020; (2) performed a reconciliation between the adjusted total costs booked and the cumulative amount billed for FY 2020 and reported any over/under-billings; (3) determined whether contract limitations as reported on the RMI's ICP Schedule I are appropriate based on costs claimed that are (a) in excess of contract ceiling rates and/or amounts; (b) unallowable per contract terms (if applicable); or (c) outside the contract's period

of performance; (4) determined whether the cumulative amount billed for each contract, as of the end of the fiscal year under review, exceeded the total funded value on the contract at that point in time; and (5) performed a risk and materiality assessment of RMI using procedures from newly enacted guidance developed by a Department of Defense Procurement Panel. Brown examined USAID Auditable Dollar Value of \$30,100,227 for FY 2020.

Brown concluded that RMI's costs claimed for in-scope contracts and subcontracts for FY 2020 are allowable, allocable, and reasonable in accordance with contract terms, Part 31 of the FAR, AIDAR, DSSR, and 2 CFR 200. Brown did not identify any direct or indirect questioned costs. Finally, Brown did not note any instances of material non-compliance with laws, regulations, or contract terms required to be reported under Government Auditing Standards during the FY 2020 audit.
