**SUBJECT:** Single Audit of Management Sciences for Health, Inc., for the Year Ended June 30, 2019 (3-000-24-044-T)

This memorandum transmits the final audit report on the single audit of Management Sciences for Health, Inc., (MSH) for the Year Ended June 30, 2019. The audit report was obtained from the Federal Audit Clearinghouse. MSH contracted with the independent audit firm BDO USA, LLP (BDO) to conduct the audit. BDO stated it performed its audit in accordance with U.S. Government accounting standards issued by the Comptroller General of the United States and Title 2 Code of Federal Regulations (CFR) Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards. BDO is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on MSH's consolidated financial statements; the effectiveness of its internal control; or its compliance with the awards, laws, and regulations.<sup>1</sup>

BDO's audit objectives were to: (1) express an opinion on MSH's consolidated financial statements; (2) obtain reasonable assurance about whether MSH's combined financial statements are free from material misstatement; and (3) express an opinion on compliance with the types of compliance requirements described in the Office of Management and Budget Compliance Supplement that could have a direct and material effect on each of MSH's major federal programs described in the Office of Management and Budget's (OMB) Compliance Supplement that could have a direct and material effect on each of MSH's major Federal programs for the year ended June 30, 2019. To answer the audit objectives, BDO: (1) obtained evidence about the amounts and disclosures in the financial statements; (2) evaluated the appropriateness of accounting policies used and the reasonableness of significant accounting

estimates made by MSH and evaluated the overall presentation of the financial statements; and (3) tested MSH's compliance with certain provisions of laws, regulations, contracts, grant agreements, and other matters which could have a direct and material effect on the determination of financial statement amounts. MSH's audited expenditures of Federal awards was \$90,416,765, of which the U.S. Agency for International Development's (USAID) audited expenditures amounted to \$88,011,659.

BDO expressed an unmodified opinion on the financial statements and on compliance for major Federal programs. Further, BDO reported that it did not find any material weaknesses or significant deficiencies in internal control over financial reporting and no material weakness in internal control over major Federal programs. However, BDO identified two significant deficiencies in internal control over awards associated with USAID Foreign Assistance for Programs Overseas, against which no questioned costs were determined, but were required to be reported in accordance with 2 CFR 200.516(a). We are not making a recommendation for the two significant deficiencies noted in BDO's audit report. However, we suggest that USAID/Management/Office of Acquisition and Assistance/Cost, Audit, and Support Division, Contract Audit Management Branch determine if MSH addressed the two significant deficiencies BDO reported.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4) ("commercial or financial information obtained from a person that is privileged or confidential"). In addition, USAID OIG has determined that this transmittal memo and the enclosed report are not subject to notification and reporting requirements under Section 5274 of the National Defense Authorization Act.<sup>2</sup>
