**SUBJECT:** Financial Audit of USAID Resources Managed by National Council of People

Living With HIV in Tanzania Under Cooperative Agreement 72062120CA00001,

July 1, 2022, to June 30, 2023 (Report No. 4-621-24-108-R)

This memorandum transmits the final audit report on USAID resources managed by National Council of People Living With HIV (NACOPHA) in Tanzania for the Hebu Tuyajenge ("Let's Discuss Constructively") program. NACOPHA contracted with the independent audit firm PricewaterhouseCoopers (PwC), Dar es Salaam, Tanzania to conduct the audit. The audit firm stated that it performed its audit in accordance with International Standards on Audit in conjunction with generally accepted government auditing standards. However, it did not have an external peer review or a continuing professional education program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on NACOPHA's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations. I

The audit objectives were to (I) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate NACOPHA's internal controls; (3) determine whether NACOPHA complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, PwC (I) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by NACOPHA as incurred from July I, 2022, to June 30, 2023; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to NACOPHA's ability to report financial data consistent with the assertions embodied in each account of the schedule of

expenditures of USAID awards; (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. NACOPHA reported expenditures of \$4,291,924 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited except for \$22,750 in ineligible questioned costs. The audit firm identified no material weaknesses in internal control; and four instances of material noncompliance. Since the questioned costs did not meet the OIG's established threshold of \$25,000 for making a recommendation, we are not making a recommendation for the questioned costs and the specifically related noncompliance findings. Nevertheless, we suggest that USAID/Tanzania determine the allowability of the \$22,750 in questioned costs and recover any amount determined to be unallowable. In addition, although we are not making a recommendation for significant deficiencies noted in the report, we suggest that USAID/Tanzania determine if the recipient addressed the issues noted.

During our desk review, we noted one area for improvement which the audit firm should address in future audit reports. We presented this area in a memo to the controller, dated July 18, 2024.

To address the issues identified in the report, we recommend that USAID/Tanzania:

**Recommendation 1.** Verify that National Council of People Living With HIV corrects the two instances of material noncompliance detailed on pages 33 to 35 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4)("commercial or financial information obtained from a person that is privileged or confidential"). In addition, USAID OIG has determined that this transmittal memo and the enclosed report are not subject to notification and reporting requirements under Section 5274 of the National Defense Authorization Act.<sup>2</sup>
