**SUBJECT:** Single Audit of International Republican Institute for the Year Ended September

30, 2021 (3-000-24-066-T)

This memorandum transmits the final audit report on the single audit of International Republican Institute (IRI) for the year ended September 30, 2021. The audit report was obtained from the Federal Audit Clearinghouse. IRI contracted with the independent accounting firm RSM US LLP (RSM) to conduct the audit. RSM stated that it performed its audit in accordance with U.S. Government accounting standards issued by the Comptroller General of the United States and in accordance with Title 2 Code of Federal Regulations (CFR) Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards. RSM is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on IRI's schedule of expenditures of Federal awards; the effectiveness of its internal control; or its compliance with the awards, laws, and regulations. I

RSM's audit objectives were to: (I) express an opinion on the financial statements; (2) obtain reasonable assurance about whether IRI's combined financial statements are free from material misstatement; and (3) express an opinion on compliance with the types of compliance requirements described in the Office of Management and Budget Compliance Supplement that could have a direct and material effect on each of IRI's major Federal programs for the year ended September 30, 2021. To answer the audit objectives, RSM: (I) obtained evidence about the amounts and disclosures in the financial statements; (2) evaluated the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, and evaluated the overall presentation of the financial statements; (3) considered IRI's internal control over financial reporting and performed tests of IRI's compliance with

certain provisions of laws, regulations, contracts, grant agreements, and other matters. IRI's audited expenditures of Federal awards was \$101,154,041, of which the U.S. Agency for International Development's (USAID) audited expenditures amounted to \$50,998,663.

RSM expressed an unmodified opinion on the financial statements and on compliance for major programs. Further, RSM reported that it did not find any deficiencies in internal control it considered to be material weaknesses or significant deficiencies in internal control over financial reporting and on internal control over major programs. Finally, RSM did not identify any audit findings required to be reported in accordance with 2 CFR 200.516(a) and did not identify any questioned costs in its Federal awards audit for IRI.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4)("commercial or financial information obtained from a person that is privileged or confidential"). In addition, USAID OIG has determined that this transmittal memo and the enclosed report are not subject to notification and reporting requirements under Section 5274 of the National Defense Authorization Act.<sup>2</sup>
