This memorandum transmits the final audit report of the schedule of expenditures of the Tomorrow Youth Organization, Women Entrepreneurship Development project in West Bank and Gaza, cooperative agreement 72029422CA00001, from February 7 to December 31, 2022. USAID/West Bank and Gaza contracted with the independent audit firm Deloitte & Touche (M.E.) to conduct the audit. The audit firm stated it performed the audit in accordance with U.S. Government Auditing Standards. However, it did not have an external quality control review program because professional organizations in West Bank and Gaza do not offer such a program. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on the auditee's schedule of expenditures; the effectiveness of its internal controls; or its compliance with the award, laws, and regulations. I

The audit objectives were to (I) express an opinion on whether the schedule of expenditures for the period audited was presented fairly, in all material respects; (2) evaluate the auditee's internal controls; and (3) determine whether the auditee complied with the award terms and applicable laws and regulations including compliance with Executive Order 13224-Blocking Property and Prohibiting Transactions with persons who commit, threaten to commit, or

support terrorism. To answer the audit objectives, the audit firm performed the subject financial audit that covered \$ 335,354 from February 7 to December 31, 2022.

The audit firm concluded that the schedule of expenditures presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited and did not identify any questioned costs. The audit firm did not identify any material internal control weaknesses. However, the audit firm identified one material instance of noncompliance with the award's terms, conditions and applicable laws and regulations. The audit firm did not identify any material instances of noncompliance with the mission order 21 and Executive order 13224.

To address the issue identified in the report, we recommend that USAID/West Bank and Gaza:

**Recommendation I.** Verify that Tomorrow Youth Organization corrects the instance of material noncompliance detailed on page 23 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision.
