
FY 2025 COMPREHENSIVE OVERSIGHT PLAN-OVERSEAS CONTINGENCY OPERATIONS



COP-OCO IN BRIEF

The annual comprehensive oversight plan is a whole-of-government effort involving Federal agencies with oversight responsibility for different aspects of overseas contingency operations. Operation Inherent Resolve (OIR) in Iraq and Syria and Operation Enduring Sentinel (OES) in Afghanistan will continue into FY 2025. This comprehensive oversight plan contains 71 ongoing and planned oversight projects for FY 2025, some of which apply to multiple overseas contingency operations.

Lead IG Oversight Objectives

- Inform Congress and the public about progress and challenges in overseas contingency operations.
- Advise the DoD, State, and USAID on the effectiveness of their missions.
- Promote the integrity, efficiency, and accountability of U.S. Government programs.
- Assess the impact of U.S. Government programs to improve U.S.-provided assistance.
- Evaluate the safety and security of U.S. installations and personnel.
