SUBJECT: Financial Audit of USAID Resources Managed by Amref Health Africa in Tanzania

Under Cooperative Agreement 72062120CA00007, January 1 to December 31,

2023 (Report No. 4-621-25-024-R)

This memorandum transmits the final audit report on USAID resources managed by Amref Health Africa in Tanzania (Amref Tanzania) for the Afya Shirikishi activity. Amref Tanzania contracted with the independent audit firm Deloitte & Touche, Dar es Salaam, Tanzania to conduct the audit. The audit firm stated that it performed its audit in accordance with international standards on audit in conjunction with generally accepted government auditing standards (GAGAS). However, it did not have an external peer review or a continuing professional education program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on Amref Tanzania's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations. I

The audit objectives were to (I) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate Amref Tanzania's internal controls; (3) determine whether Amref Tanzania complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, Deloitte & Touche (I) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by Amref Tanzania as incurred from January I to December 31, 2023; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to Amref Tanzania's ability to report financial data consistent with the assertions embodied in each account of the schedule of expenditures of USAID awards; (3) identified the award terms and

pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. Amref Tanzania reported expenditures of \$3,104,646 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited. The audit firm identified no questioned costs; no material weaknesses in internal control; and two instances of material noncompliance (one which was a repeat finding from the prior period and will not be included as a recommendation again). In addition, although we are not making a recommendation for significant deficiencies noted in the report, we suggest that USAID/Tanzania determine if the recipient addressed the issues noted.

To address the issues identified in the report, we recommend that USAID/Tanzania:

Recommendation 1. Verify that Amref Health Africa corrects the one instance of material noncompliance detailed on pages 41 to 44 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4)("commercial or financial information obtained from a person that is privileged or confidential").
