**SUBJECT:** Financial Closeout Audit of USAID Resources Managed by West African Health Organisation in Multiple Countries, Under Cooperative Agreement AID-624-A-15-00001, January 1 to June 30, 2023 (Report No. 4-624-25-020-R)

This memorandum transmits the final closeout audit report on USAID resources managed by West African Health Organisation (WAHO) under Leadership Capacity Strengthening Project. WAHO contracted with the independent audit firm PricewaterhouseCoopers, Accra, Ghana to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards (GAGAS). However, it did not have an external peer review and continuing professional education programs that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on WAHO's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.<sup>1</sup>

The audit objectives were to (1) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate WAHO's internal controls; (3) determine whether WAHO complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, PricewaterhouseCoopers (1) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by WAHO as incurred from January 1 to June 30, 2023; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to WAHO's ability to report financial data consistent with the assertions embodied in each account of the schedule of expenditures of USAID awards; (3) identified the award terms and

pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. WAHO reported expenditures of \$841,123 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited. The audit firm identified no questioned costs; two material weaknesses in internal control; and no instances of material noncompliance.

During our desk review, we noted one area for improvement which the audit firm should address in future audit reports. We presented this area in a memo to the controller, dated November 13, 2024.

To address the issues identified in the report, we recommend that USAID/West Africa:

**Recommendation 1.** Verify that West African Health Organisation corrects the two material weaknesses in internal control detailed on pages 17 and 18 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4) (“commercial or financial information obtained from a person that is privileged or confidential”). In addition, USAID OIG has determined that this transmittal memo and the enclosed report are not subject to notification and reporting requirements under Section 5274 of the National Defense Authorization Act.<sup>2</sup>
