SUBJECT: Financial Audit of USAID Resources Managed by Kenya Conference of Catholic Bishops Under Cooperative Agreement 72061519CA00007, January 1 to December 31, 2023 (Report No. 4-615-25-077-R)

This memorandum transmits the final audit report on USAID resources managed by Kenya Conference of Catholic Bishops (KCCB) under Komesha TB Program. KCCB contracted with the independent audit firm Deloitte & Touche LLP, Nairobi, Kenya to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards. However, it did not have an external peer review or a continuing professional education program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on KCCB's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.¹

The audit objectives were to (1) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate KCCB 's internal controls; (3) determine whether KCCB complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, Deloitte & Touche (1) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by KCCB as incurred from January I to December 31, 2023; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to KCCB's ability to report financial data consistent with the assertions embodied in each account of the as applicable: schedule of expenditures of USAID awards; (3) identified the award terms and

pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. KCCB reported expenditures of \$446,290 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the award for the period audited except for \$17,770 in total questioned costs (\$4,051 ineligible and \$13,719 unsupported); no material weaknesses in internal control; and four instances of material noncompliance (two which relates to the questioned costs). Since the questioned costs did not meet the OIG's established threshold of \$25,000 for making a recommendation, we are not making a recommendation for the questioned costs. Nevertheless, we suggest that USAID/Kenya and East Africa determine the allowability of the \$17,770 in questioned costs and recover any amount determined to be unallowable. In addition, although we are not making a recommendation for significant deficiencies noted in the report, we suggest that the mission determine if the recipient addressed the issues noted.

To address the issues identified in the report, we recommend that USAID/Kenya and East Africa:

Recommendation 1. Verify that Kenya Conference of Catholic Bishops corrects the two instances of material noncompliance detailed on pages 46 to 48 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision.
