SUBJECT: Financial Audit of USAID Resources Managed by Moi Teaching and Referral Hospital in Kenya Under Multiple Awards, July 1, 2024, to June 30, 2025 (Report No. 4-615-26-021-R)

This memorandum transmits the final audit report on USAID resources managed by Moi Teaching and Referral Hospital (MTRH) under Cooperative Agreements 72061521CA00020 (AMPATH Uzima Project) and 72061522CA00001 (Dumisha Afya Project). MTRH contracted with the independent audit firm Deloitte & Touche LLP, Nairobi, Kenya to conduct the audit. The audit firm stated that it performed its audit in accordance with the U.S. Government Auditing Standards issued by the Comptroller General of the United States (GAGAS). However, it did not have an external peer review or a continuing professional education program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on MTRH's schedule of expenditures on USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.¹

The audit objectives were to (1) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate MTRH's internal controls; (3) determine whether MTRH complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, Deloitte & Touche LLP (1) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs

reported by MTRH as incurred from July 1, 2024, to June 30, 2025; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to MTRH's ability to report financial data consistent with the assertions embodied in each account of the schedule of expenditures of USAID awards; (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. MTRH reported expenditures of \$13,408,926 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the awards for the period audited. The audit firm identified \$132 in unsupported questioned costs; no material weaknesses in internal control; and three instances of material noncompliance. Since the questioned costs did not meet the OIG's established threshold of \$25,000 for making a recommendation, we are not making a recommendation for the questioned costs and the specifically related material noncompliance instance. Nevertheless, we suggest that the agency determine the allowability of the \$132 in questioned costs and recover any amount determined to be unallowable. The audit firm also issued a management letter.

To address the issues identified in the report, we recommend that USAID:

Recommendation I. Verify that Moi Teaching and Referral Hospital in Kenya corrects the two instances of material noncompliance detailed on pages 36 to 39 of the audit report.

We ask that you provide your written notification of actions planned or taken to reach management decision.
