SUBJECT: Financial Audit of USAID Resources Managed by Partners in Hope in Malawi
Under Multiple Awards, October 1, 2023, to September 30, 2024 (Report No. 4-
612-26-028-R)

This memorandum transmits the final audit report on USAID resources managed by Partners in Hope (PIH) under the following awards: 1) Client Oriented Response for HIV Epidemic Control (CORE) project, cooperative agreement 72061221CA00010; and 2) TB Local Organization Network One (TB Lon 1) project, cooperative agreement 72061221CA00012. PIH contracted with the independent audit firm Bakertilly, Lilongwe, Malawi to conduct the audit. The audit firm stated that it performed its audit in accordance with the U.S. Government Auditing Standards issued by the Comptroller General of the United States (GAGAS) and International Standards on Auditing (ISA). However, it did not have an external peer review or a continuing professional education program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on PIH's schedule of expenditures on USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations.¹

The audit objectives were to (1) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate PIH's internal controls; (3) determine whether PIH complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, Bakertilly (1) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received

from USAID for the period covered by the audit and the costs reported by PIH as incurred from October 1, 2023, to September 30, 2024; (2) evaluated the control environment, the adequacy of the accounting systems, and control procedures that pertain to PIH's ability to report financial data consistent with the assertions embodied in each account of the schedule of expenditures of USAID awards; (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined that the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. PIH reported expenditures of \$17,371,507 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the awards for the period audited. The audit firm identified no questioned costs; no material weaknesses in internal control; and no instances of material noncompliance. In addition, although we are not making a recommendation for significant deficiencies noted in the report, we suggest that USAID determines if the recipient addressed the issues noted. The audit firm also issued a management letter.

Accordingly, we are not making any recommendations.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4) ("commercial or financial information obtained from a person that is privileged or confidential"). In addition, USAID OIG has determined that this transmittal memo and the enclosed report are not subject to notification and reporting requirements under Section 5274 of the National Defense Authorization Act.²
